2. Owner acknowledges that it is impossible to predict with certainty the prices which will be received for Auctioned items. Accordingly, no such representation is made by Company. Company and its agents are authorized by Owner to purchase items at subject auctions.
3. Owner warrants title and the right to sell all property to be sold free of encumbrances and assumes responsibility for representations made by Owner or Auctioneer. Company is authorized to execute documents of transfer for Owner. If any items or property is subject to mortgage, lien, or claim, Company shall have the right, at its discretion, to distribute the proceeds either jointly or directly to such mortgages, lien holders, or claimants, and to deduct such payment from Owners share.
